- · Secondment to armed forces no time limit, secondment anywhere in the world excluding armed forces three years maximum cover, career break five years maximum cover.
- · Cover for children is automatically provided on our product. The benefit provided is 25% of the officer's benefit.
- The survival period is 14 days, except for TPD claims, where the member must have been continuously and permanently disabled for six months before we will pay the lump sum.
